## 2011 Resident Swimming Pool Pass Application

### PLEASE NOTE:

- **POOL PASSES ARE PERMANENT. PLEASE SAVE THEM FOR FUTURE SEASONS. RENEWAL STICKERS WILL BE ISSUED PRIOR TO EACH POOL SEASON.**
- **PASSES THAT ARE LOST OR MISPLACED WILL BE REPLACED FOR A CHARGE OF \$10 PER CARD. THIS DOES NOT APPLY WHEN A RESIDENT MOVES INTO ANOTHER AGE CATEGORY FOR PASS DISTRIBUTION.**
- Note: If you have retained your pool passes from last year, fill out your name and address and part B for your 2011 renewal stickers.
- **ALL APPLICATIONS MUST BE FILLED OUT CORRECTLY** in order to get your pool passes for opening day.
- **POOL PASSES WILL BE HELD FOR THOSE RESIDENTS THAT ARE THIRTY (30) DAYS OR MORE OUTSTANDING ON THEIR HOA DUES OR HAVE OUTSTANDING MAINTENANCE OR ARCHITECTURAL VIOLATIONS**
- The pool will open **Saturday, May 28, 2011. (Memorial Day Weekend)** The pool will be open on certain dates and hours during the two week period past Labor Day Weekend. Additional hours will be posted on the website and at the pool.
- Pool hours while Montgomery County schools are in session will be **Monday, Wednesday, and Friday from 3 p.m. – 8 p.m., Tuesday and Thursday from 4 p.m. – 9 p.m., Saturday, Sunday, and Holidays from 10 a.m. – 8 p.m.**
- Pool hours while Montgomery County schools are on summer break are: **May 28 – July 31: Monday, Wednesday, and Friday from 10 a.m. – 8 p.m.; Tuesday and Thursday from 11 a.m. – 9 p.m.; Saturday, Sunday, and Holidays from 10 a.m. – 8 p.m. August 1 – August 29: Monday – Friday, 12 noon – 8 p.m. and Saturday and Sunday, 11 a.m. – 8 p.m.**
- Each address will receive (1) One Guest Pass with (10) guest visits on it.
- Additional guest passes (10 visits/card) can be purchased at the pool office for \$10. (By Check Only!)
- In order to ensure that your pool passes are processed in time for pool opening, please be sure to submit your application by no later than May 1, 2011. Applications received after this date will be processed as quickly as possible, but we cannot guarantee that your passes will be mailed to you before the pool opens.
- Beginning May 16, 2011, walk in pool pass processing hours are 9:00 a.m. – 4:00 p.m. Monday thru Thursday; Friday 9:00 a.m. – 2:30 p.m. **Please note that walk-in pool pass processing fees are as follows:** If required within 24 hours-\$25.00; if required while you wait-\$40.00.

**RESIDENT CERTIFICATION FOR POOL PASSES:** I hereby certify that the information supplied above is accurately stated and I am requesting resident passes only for **FULL TIME** residents of the address above. Upon signature of the application, I acknowledge that my family, my guests and I will abide by the Rules and Regulations governing the use of the swimming pool facility.
